Other Education and Professional Training:

- ***Graduate Biostatistics I / II***, Vanderbilt University School of Medicine (Fall 2014 / Spring 2015). Graduate level biostatistics courses that are part of the Master of Science in Clinical Investigation program at Vanderbilt. Courses cover the breadth of biostatistical knowledge necessary for conducting and evaluating biomedical basic and clinical research. Courses include advanced regression/modeling techniques, as well as common biostatistical methods including power analysis and sample size considerations. The course is an intensive introduction to the software program R/R-studio for all data analysis and visualization purposes with emphasis on reproducible research.
- ***Isotope Tracers in Metabolic Research***, National Institutes of Health / Case Western Reserve University, Cleveland, OH (November 2014). Course provides basic introductory as well as comprehensive information on performing metabolic studies using radioactive or stable tracers in humans and animals. Techniques discussed include investigating whole-body metabolism (carbohydrate, lipid, protein) as well as metabolite balance across organs, intracellular flux rates, and pathway regulation/kinetics.
